The I-20 or DS-2019 will be issued by the University upon admission and confirmation to enroll at the University of Notre Dame.



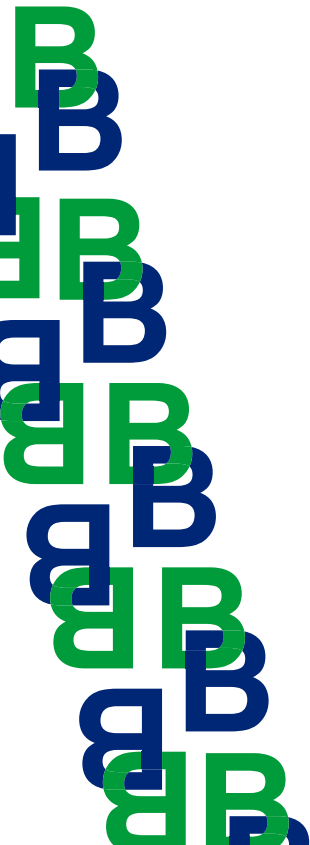
